## **Canterbury City Council Museums and Galleries Service 2014 Contract Terms and Conditions of Image Supply for Reproduction**

The contract is between Canterbury City Council Museums & Galleries (the Council) and the applicant for permission (the Licensee) to reproduce an item (the Image) in the Council's collections.

The contract sets out the Council's Terms and Conditions of licence and the Licensee agrees to comply with them and signs the contract to this effect. Any reproduction of any of the Council's images by the Licensee implies acceptance of these Terms and Conditions. The Council's licence sets out the specific Rights provided to the Licensee and the payments due to the Council.

Permission to reproduce will automatically be withdrawn if any of these Terms and Conditions is infringed, or the Rights of the attached licence exceeded or misused.

1. Permission to Reproduce the images is strictly limited to the specific uses detailed in the attached licence, and this permission is not transferable for other uses nor to other users at any time.
2. The Rights that are granted to the Licensee are non-exclusive.
3. All reprints, further edition or other use of the image, other than for the purpose, necessitates a new application to the Council and payment of a further fee, unless otherwise agreed on the licence itself.
4. Unless otherwise agreed the Licensee may hold the image for one month from the issue date after which the Licensee will return the image or deal with it in the way specified in the licence. A late fee of £20 plus VAT will be charged per overdue week.
5. Copyright in the image remains the property of the Council unless otherwise stated. Images of works of art by living artists or artists who died less than 70 years ago can only be supplied if the Licensee has obtained written consent from the owner of the copyright in the work of art, a copy of which must be sent to the Council before the image can be released.
6. Damage to the image however caused, loss, or failure to return it to the Council will incur a charge of £50 plus VAT to provide a replacement for the Council.
7. The Image must not be cropped, edited, be superimposed with type or other material, or have any part deleted or in any way defaced without prior written permission of the Council.
8. The image/s supplied, including digital image/s, will not be stored by the Licensee or the Licensee's printer/publisher after this specific use and any working copies or digital images will be destroyed or returned to the Council as directed by the Council
9. If the image or any work reproduced in the image has not previously been published then any publication rights therein are hereby assigned absolutely to the Council for the full period of such publication rights.
10. Each reproduction of an Image must carry beside it the acknowledgment exactly as it is set out in the attached licence, or in such other format as the Council agrees in writing. A copy of the acknowledgement must be submitted to the Council for approval before publication. Failure to comply with any of the requirements in this clause will result in payment by the Licensee of a penalty fee of £100 plus VAT
11. Payment of fees and VAT must be received from the Licensee before any image is despatched. Payment should be by cheque payable to Canterbury City Council and drawn on British bank, or by another method agreed by the Council in advance
12. A complimentary copy of the publication or product for which the licence is granted is to be supplied on publication to the Council at the museum address.
13. Variations, amendments, additions or deletions to these Terms and Conditions may only be made if agreed in writing by both parties.
14. The Council's failure to exercise or enforce any of its rights under these Terms and Conditions (or otherwise) will not be deemed to be a waiver of any such rights

nor will that failure operate so as to bar the future exercise or enforcement of those rights.
