## **FUNERAL**

### **MRS. PENN.**

*Age 86 (subd)*

The funeral of Mrs. Ellen Penn took place yesterday at Lee. The body was placed in the family vault at St. Margaret's Church, where the Rector (the Rev. R. Meddings) and the Vicar of Lewisham (Canon Hough) officiated. Among the other clergymen present were Canon Rhodes Bristow and the vicars of Christ Church, Lee, and the Church of the Good Shepherd, Lee.

The mourners were Mr. William Penn, Mr. Frank Penn (sons), Mr. J. F. Green, Mr. F. Stokes (sons-in-law), Captain Frank Penn, 2nd Life Guards (grandson), Mr. Eric Penn, Mr. Geoffrey Penn, Captain and Mrs. Young, Captain and Mrs. Longueville, Lieutenant Alec Stokes, R.N., Captain John Campbell, Mr. Stewart Bowles, and Mr. W. Hartree. Sir James Goodheart, Dr. Arthur Roper, Lady Hutchinson, Captain-F. Liebenrood, Sir Edward Coates, M.P., and Dr. J. E. Burroughs were also present.

## THE FOUR-IN-HAND CLUB.

### MEET IN HYDE PARK.

The Four-in-Hand Club held its one meet of the present season yesterday, when 14 coaches forgathered at the Magazine in Hyde Park. The club had held its annual dinner at the Carlton Hotel overnight, when Lord Desborough, the new president, was in the chair, and the entertainment had been a most successful one. The meet of the coaches was equally successful, even though the weather was dull, and rain began to fall just as the coaches were leaving.

The president drove a powerful bay team, and had with him Lady Helen Grosvenor, Lord Londonderry, Lord Charles Beresford, the Hon. Monica Grenfell, Miss Aylmer, and Mr. Warre. He was not the first to arrive, however, for Lord Hollenden—well known in the driving world as Mr. Hope Morley—was the first member on the parade ground, and his magnificent team of Cleveland bays was greatly admired. These horses are probably the finest team of their breed which has ever been seen at a coaching meet, and the wheelers have all the best Cleveland bay characteristics of great length, with wonderful limbs, and about the best feet that were ever seen on coach-horses. With Lord Hollenden were Lady Hollenden, Lady Altamont, Mr. Birch, and the Hon. Claude and Lady Dorothy Hope Morley. Sir Edward Stern drove, as usual, blue roans of hackney type, and had on his coach Lady Stern, Sir Gilbert and Lady Parker, and others; and Colonel Sir Alfred Somerset drove chestnuts in snaffle bridles, and had with him Lady Somerset, Mr. Fitzroy Somerset, Colonel Curzon, and others. Mr. Alan Lupton, a new member of the Four-in-Hand, but an old member of the Coaching Club, had before him a workman-like black team, and on his coach were Mrs. Lupton, Sir Charles and Lady Lowther, Lady Burrell, and Mr. Adrian Hope.

These were the earliest drags on the spot, and they were succeeded by the regimental coach of the 2nd Life Guards, driven by Captain Frank Penn, and horsed by a bay team. On the box seat were Princess Alexander of Teck, and behind her Lady Edith Trotter, the Hon. Mrs. A. Strutt, the Hon. Mrs. Montgomerie, and Messrs. Murray Smith, Bethel, and Sheed. ### **DEATH OF MR. FRANK PENN.**

---

Mr. Frank Penn, whose death is announced at Biltons, Canterbury, aged 65, had a short but very brilliant cricket career, ranking for several years among the finest batsmen of the day. He had a free, commanding style and combined strong defence with splendid hitting powers. Unfortunately his health gave way just when he was at the height of his fame. In the season of 1881 he was attacked by an affection of the heart, and, being forbidden to run, had to give up the game.

Among those who helped Lord Harris to re-establish Kent cricket no one did better work than Mr. Penn. He made many big scores for Kent, the highest being 100 against Surrey at Maidstone in 1878, 148 against Surrey at the Oval in 1877, and 135 against England at Canterbury in 1877. Perhaps the innings of his life, however, was 134 at Lord's for M.C.C. against Cambridge University in 1879, when he treated Mr. A. G. Steel's bowling as it had never been treated before. He had finished with cricket before Test Matches became frequent, but it was his privilege to play for England against Australia at the Oval in September, 1880, in the first of the long series of contests in this country. He scored 23 and not out 27, and made the hit that gave England a victory by five wickets in that memorable game. Mr. Penn was a member of Lord Harris's team in Australia in 1878-9. He appeared eight times for Gentlemen v. Players, batting well but without any conspicuous success. His best score was 52 at the Oval in 1876.

He exhibited in the Royal Academy from 1865 to 1877, and for the four following years at the Grosvenor Gallery. In 1881 he was appointed Director for Art in the Department of Science and Art, retaining this office until 1898. He was made a C.B. in the latter year. Among his paintings were "Feeding Pigeons," "A Girl Holding an Embroidery Frame," "The Harbour Bar at Teignmouth," and "The Riviera of Genoa in Spring." He married in 1881 Alice Mary, daughter of Colonel J. J. Brine, of Torquay.

#### MR. W. MURRAY GUTHRIE.

Mr. Walter Murray Guthrie died yesterday at his residence, Duart Castle, Isle of Mull, after a long illness.

He was born in 1869, and was a son of the late Mr. J. A. Guthrie, of Craigie (a director, and at one time Governor, of the Bank of England), by his marriage with Ellinor, daughter of Admiral Sir James Stirling. He was educated at Eton and Trinity Hall, Cambridge. From 1899 to 1906 he sat in the House of Commons as Conservative member for the Bow and Bromley Division of the Tower Hamlets, retiring at the General Election in the latter year. From 1903 to 1909, when, owing to ill-health, he resigned, he was Alderman of Cornhill Ward in the City of London. He served during part of the Boer War in the Field Ambulance operations. He was a partner in the firm of Messrs. Chalmers, Guthrie, and Co., of Idol-lane, a director of the London Joint Stock Bank, of the Commercial Union Assurance Company, and of the National Discount Company, one of his Majesty's Lieutenants of the City of London, and a member of the Merchant Taylors' Company.

He married, in 1894, Olive Louisa Blanche, youngest daughter of Sir John Leslie, first baronet, of Glaslough, and Lady Constance Leslie, sister of the fourth Earl of Portarlington. There were two sons and two daughters of the marriage. One of his sisters is Lady Rodd, wife of the British Ambassador at Rome, and another is the Hon. Mrs. Edward Montagu-Stuart-Wortley, of Highcliffe Castle, Christchurch. His elder brother, Mr. D. C. Guthrie, was Liberal member for South Northamptonshire from 1892 to 1896.

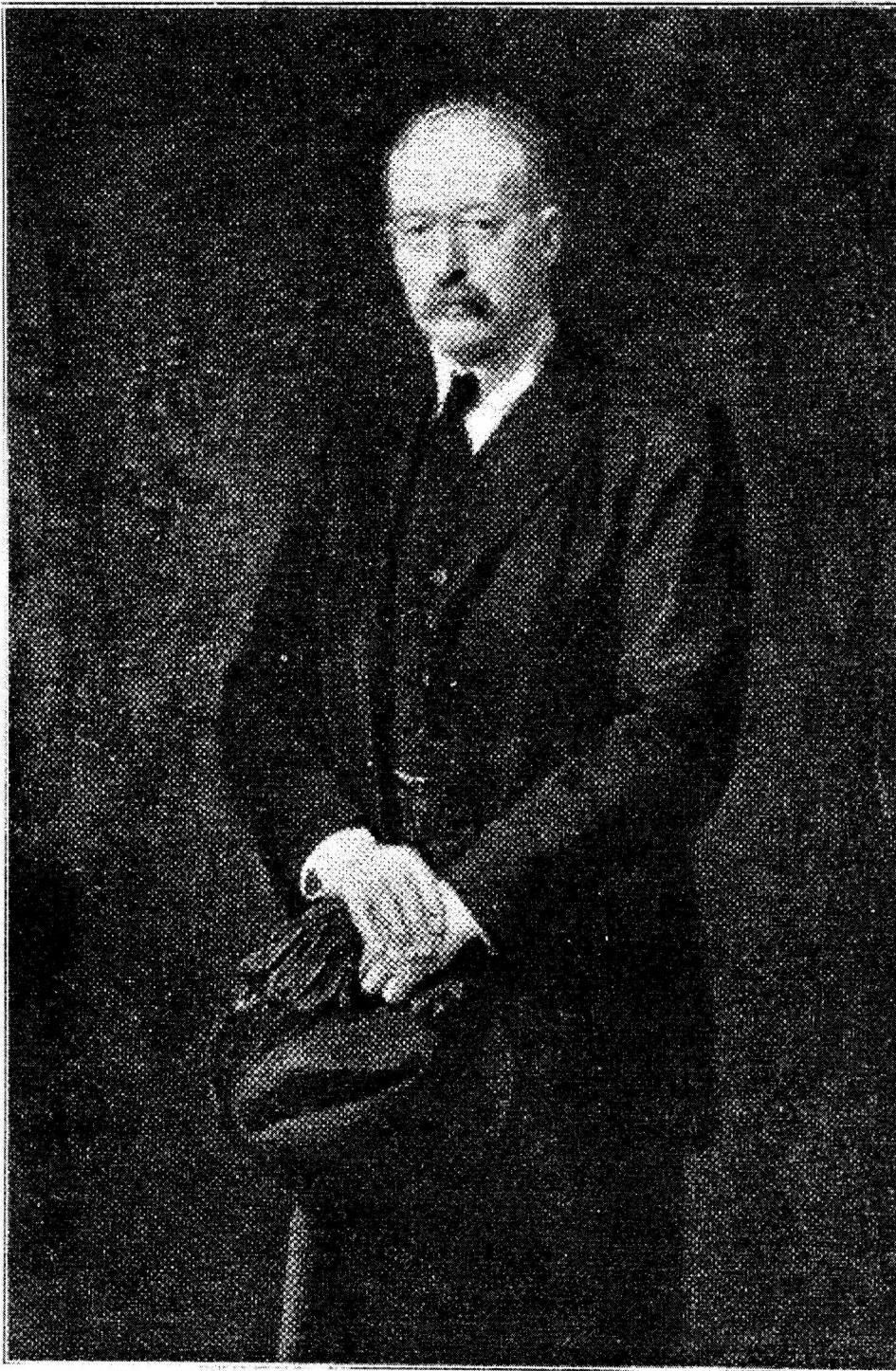
