Shall in her bed Room to be delivered to her immediately on my death And as well as the Rest RESIDUE of my Estate after payment of my debts and funeral expences I give and bequeath the same and every part thereof to my nephew Nathaniel Hooker by Deed as in my Carpenter and Shoewer's certificate and appoint him sole EXECUTOR of this my Will and revoke all former Wills by me at any time heretofore made and declare this to be my only last Will and Testament In witness whereof I have caused my name to be written the seventh day of September our thousand eight hundred and twenty five -
Paul Hooker I signed sealed published and declared by the said Testator Paul Hooker as and for his last Will and Testament in the presence of us who in the presence and at the request and in the presence of each other have signed our names as Witnesses And: *Duncan Grayson* & *James Reid* his Clerk

Proved at Lowell 30 April 1880 before the Honorable John D. Sawyer a Doctor of Law and Judge of the Court of Probate for the County of Middlesex the said Testator to whom Administration was granted having been first sworn into Administration.

I *Thomas Jordan* of the City of Salem Burgomaster being of sound and disposing mind memory and understanding do make and publish my last Will and Testament in manner and form following that is to say I give and bequeath to Henry Baker my Clerk the sum of twenty pounds to William Henry Eastwick Junior my Silver Watch and appendages and to Sarah Eastwick and Mary Ann Eastwick the two Sisters a Gold Watch of the value of ten pounds each as a token of remembrance And Direct my just debts funeral and testamentary expences to be paid by my Executor hereinafter named and after payment and satisfaction thereof I give devise and bequeath all the Rest RESIDUE and Remainder of my Estate and Effects of what kind or of what nature or quality a parcel or parcels and whatsoever the same are or may be divided into my said Son Sarah to hold the same and every part thereof to my said Son with Sarah his heirs Executors Administrators and assigns to and for the use and their own proper uses and benefit during all my personal and future term and estate and according to the nature and quality of my said Estate and Direct therein And I do hereby nominate constitute and appoint my said Wife Sarah Robert Dyer of the City of Salem aforesaid Merchant and William Henry Eastwick Junior of Haverham in the County of Essex aforesaid Executors of this my Will And it is my Will and I do hereby request my Executors and Assignors not to join in any bill of my Estate of and in a certain freehold Estate called the Straits & high ways and being near the Town of Chiswell in the County of Essex under the direction and management of John Court Esquire the attornies Executor upon the Will of my late father Thomas Jordan unless my Original Plans in the said State and within my said Son's years time by my Assignors to the said John Court or some part of my family for the sum of twenty pounds is returned to my said Executors or Assignors or repayment of the said sum of twenty pounds with lawful interest on the same from the time of date And it is my Will and I do hereby direct that my said Executors Robert Dyer and William Henry Eastwick shall reimburse themselves all Expences out of my Estate and Effects And that they shall be respectively in no answerable only for their own respective acts and deeds And lastly I do hereby revoke and make void all former and other Wills and Testaments by me at any time heretofore made and declare this and this alone to be my last Will and Testament In witness whereof I the said Thomas Jordan have caused my name and affixed my seal the tenth day of June in the year of our Lord one thousand eight hundred and twenty five
Thomas Jordan I signed sealed published and declared by the said Testator Thomas Jordan as and for his last Will and Testament in the presence

of us who at his request in his presence and in the presence of each other have
subscribed our names as witnesses unto Charles Giggell & Clement in

Copie of Sarah Jordan Widow the Relict Robert Rose and Henry Eastwick the
Sole Executors to whom Administration was granted having been first sworn by
Commission duly to administer.

declare for the same do make this my last Will and Testament in the manner and
form following that is to say first and principally I do give and bequeath my soul to God

direction of my Executor hereinafter named and as touching such worldly goods
as God of his Goodness hath bestowed upon me I give devise and bequeath the
same as follows (that is to say) I give devise and bequeath unto my Brother
William Ellis of Overland in the Parish of Doughton under Bleau all that
piece or parcel of Grounds deep Earth or Law containing one acre more or less
situated and lying at Overland in the Parish of Doughton under Bleau and
also all the Stock and Crop upon it also four hundred pounds in the hand for my
debts and all my just debts funeral expenses the charges of proving and executing
of this my last Will shall have been paid. All the Rest of my Personal Property
Household Furniture goods Chattels effects debts due and owing to me I do give
for my use and all other my personal Estate real personal and whatsoever and of
what kind and nature soever the same may be unto my said brother William
Ellis whose name I do name or assign for ever and lastly I do hereby nominate
constitute and appoint Frederick Colgate of the Parish of Burgh in the County of
West Dunkeeper sole Executor to this my last Will and Testament thereby
revoking and making void all and every other Will or Wills at any time heretofore
made by me made and do declare this to be my last Will and Testament And for
the purpose of executing this my last Will and Testament I give devise and bequeath
to the aforesaid Frederick Colgate five pounds in lawful money of the Kingdom
of Great Britain I have hereunto set my hand and seal this twenty ninth day of
January our thousand eight hundred and thirty Sarah Irons Esq. signed
sealed declared and published by the above named Sarah Irons as and for her
last Will and Testament in the presence of us who at her request and in her
presence and in the presence of each other have subscribed our names as we
witnesses hereunto Rich^d Bromley & Ann Challerast & James
Hidms.
